NAMPO CAPE 2024: WEDNESDAY 11 SEPTEMBER – SATURDAY 14 SEPTEMBER 2024

Exhibitors are kindly requested to take note of the following points regarding the upcoming NAMPO Cape 2024;

2. BUILD-UP OF EXHIBITIONS

An increasing number of exhibitors tend to leave the preparation of their stands to the last minute, leading to overcrowding on the Tuesday preceding the show. Please take note of the following very important info regarding the build-up;

Construction of sites

- Exhibitors in the halls will have access to their exhibition stands from Sunday 8 September 2024.
- Exhibitors on outdoor stands will have access to theirs stands for the construction of exhibitions from Friday 30 August 2024.
- Exhibitors who have ordered tents will have access to their tents from Friday 6 September 2024.
- Contractors and exhibitors who build their own stands will have access to the halls from Monday 2 September 2024.
- Finishing work can still be done over the weekend and on Monday, but no physical construction work.
- All sites must be completed by Tuesday 10 September 2024 at 14h00.

All exhibitions must be completed by Tuesday 10 September 2024, at 14h00. No exhibitors and building of exhibitions will be allowed after this time and the gates will close at 14h00 for all exhibitors and vehicles. Please consider carrying out the final preparation work over the weekend and on the Monday. Please also refrain from using another exhibitor's stand to load and/or off-load your equipment and/or moving across another exhibitor's stand.

Exhibitors are also requested to remove all pallets, cardboards boxes, ext. in which exhibition material and/or products are packed, from their stands on the







Tuesday before the commencement of NAMPO Cape 2024, in order to ensure that the terrain is clean before the opening of NAMPO Cape 2024 on the Wednesday.

3. REMOVAL OF EXHIBITIONS

Exhibitor's may only dismantle exhibition stands from 14h00 on the Saturday afternoon, 14 September 2024. GL Events Exhibitions and Expoguys will start dismantling stands thereafter.

4. LOADING AND OFF-LOADING OF EQUIPMENT AND GOODS AT STANDS

Exhibitors may not transport exhibition equipment to and from their stands during the official show hours. Extraordinary deliveries (replacement of stock only) to stands will only be allowed between 06h30 and 07h30 every day from Thursday through Gate 5 only.

Please note that exhibitors/contractors can offload equipment in the off-load zone near Gate 5. All trucks and trailers must be parked in the Truck Parking area near Parking 4.

Management urge exhibitors to keep in mind that weather especially strong winds can occur from time to time. Tents with glass panels have a lower wind rating and can have an effect on your exhibition. The safety office monitor wind speeds and can close tents for occupation given the specific ratings.

If you make use of your own contractors they must be available within 45 minutes to repair damages or construction.

6. DISTRIBUTION OF PAMPHLETS AND OTHER PROMOTIONAL ITEMS

Exhibitors are not allowed to distribute pamphlets or leaflets, except from their own stands. Also, no advertising boards or banners may be put up or displayed at any place on the grounds or in the parking area, except within the boundaries of an Exhibitor's own stand.

7. SHOWTIME'S AND CLOSING OF GROUNDS

Please note that Bredasdorp Park will open at 07h15 for exhibitors and 08h00 for the public and close at 17h00 for the public and 17h30 for exhibitors every day.

Exhibitions must be manned and ready for business as from 08h00 until 17h00. Please advise your representatives accordingly. **No exhibitors and/or visitors will be allowed on the premises after closure at 18h00.**

8. MEDICAL SERVICES BEFORE & DURING NAMPO CAPE 2024

Medical services will be available at NAMPO Cape from 9 – 14 September 2024. Exhibitors will be responsible for any medical accidents that may occur on stands before the said date.

9. HEALTH & SAFETY OFFICER

The NAMPO Cape management has appointed a Health & Safety Officer for NAMPO Cape 2024 from 9 – 10 September 2024, who will be responsible for the inspection of







stands and to see if it meets the necessary legal requirements. The same rules and regulations that apply to building sites will also apply here.

10. SOFT DRINKS, FOOD & BARISTAS

No food or beverages may be brought onto the Bredasdorp Park terrain by exhibitors, but can be bought on the terrain at kiosks.

No kettles, percolators or baristas will be allowed on any stands. Exhibitors who would like to make a table booking can contact one of the following food kiosks on the terrain;

13. ELECTRICITY, WATER & LOAD SHEDDING

Exhibitors are urged to contact Bredasdorp Park at 028 – 050 1385 or Hendrik van Wyk at 066 200 5312 for all your electricity and water requirements. Please note that all the outdoor exhibitors must bring a lead of not less than 30 metres to get access to an electricity box.

All the 3 phase points will have 16 amps and not 32 amps. The 3 phase outlet socket will be a 16 amps 5 points socket. **No generators will be allowed on stands**.







When Eskom implement load-shedding during NAMPO Cape 2024, then backup generators will supply Bredasdorp Park with electricity during load-shedding.

17. SECURITY & TEMPORARY WORKERS

Temporary workers will be issued with a bibby. The bibbie's will be available from Monday 2 September 2024, till Tuesday 10 September 2024 at the Info Office in the BKB Hall. If you bring your own workers, then these workers should be registered at the Security Office from Monday 2 September 2024, should they not wear company branding.

Exhibitors will only be allowed to make use of the official security firm appointed by the NAMPO Cape management and will not be allowed to make use of their own attendants. No person will be allowed to stay or sleep in exhibitions overnight (after closing of halls and the show). This rule is not applicable to the livestock exhibitors who, within the applicable rules, may have herdsmen on the terrain during the night.
